1 Targets

2 Compliance with the laws

This includes reducing energy requirements, emissions and waste in all areas of the company.

All employees in procurement and environmental management ensure, based on environmental guidelines and laws, that the environmental compatibility of our partners and suppliers is increased.

5.2 Energy efficiency and renewable energy

In order to reduce the ecological footprint of our products, we measure and evaluate our main energy consumption in order to exploit the savings potential. When purchasing new or converting systems, we always pay attention to high energy efficiency.

5.3 Water management, water consumption

Water is an increasingly scarce resource. That's why MERO-TSK handles water responsibly in terms of extraction, consumption and discharge. The risk of contamination of rainwater on our company premises is minimized by implementing environmental protection regulations. Through responsible chemical management, we ensure that no pollutants reach surface water or groundwater.

5.4 Waste prevention, reuse and recycling



Here we only work with certified and licensed waste disposal companies in order to be able to display waste balances via digital waste recording. This serves to achieve goals and comply with legal documentation requirements.

5.5 Greenhouse gas reduction

The focus is on the use of electricity from renewable energies and the modernization of systems and processes. We record and report the consumption and savings of greenhouse gas emissions as part of our environmental management system.

MERO-TSK has introduced an environmental management system in accordance with DIN EN ISO 14001:2015. We record the impact of our products on the environment. From this, goals are formulated and measures for improvements are developed.
